Director's Report

Financial Reports & Review – For December 31, Low Rent was over budget by \$15,610.34, under for Admin. Fee by \$4,536.07 and Under for HAP by \$6,159, Prairie Haven was under by \$8,502.73, Washburn was under by \$482.14, Prairieton was under by \$2,058.53, and Management Fund over by \$715.99. Vice-Chr. Boschulte made a motion to approve as presented and reviewed, 2nd by Com. Greenhalgh, motion carried.
